## **GMO Statement for ADM Soy Lecithin Products**

The Archer Daniels Midland Company (ADM) procures soybeans in North America under standard purchase contracts either directly from growers, from farmer cooperatives or from other dealers. The procurement contracts call for the delivery of either number one graded yellow soybeans under USDA standards or number two yellow soybeans under Canadian standards. These soybeans may or may not contain genetically modified organisms. In North America, there is no distinction made between traditional and genetically derived varieties of soybeans. Unless the products purchased from ADM are specifically identified as being produced under the terms and conditions of ADM's IP Program for Soy Ingredients the soybeans used for production of soy lecithin products will be procured as described above.

Upon request and subject to availability, ADM will offer for sale lecithin products that an independent testing laboratory has tested and found representative samples thereof to be below the detection limits for the glyphosate tolerance trait (Roundup Ready®) DNA sequence by PCR (polymerase chain reaction) testing. This product has been produced from soybeans sourced as described in the above paragraph, but has been found to be "DNA Negative".

The ADM Documented Identity Preservation Program (IP Program) for soy ingredients is designed to procure Non-Genetically Modified (Non-GM) soybeans and to preserve their identity throughout all subsequent phases of the production process. Soy lecithin produced under this program is tested for the adventitious presence of nine-tenths of one percent (0.9%) or less of the glyphosate tolerance trait (Roundup Ready®) DNA. This program is routinely audited and certified by an independent organization. A copy of our Documented Identity Preservation Program for Soy Ingredients is available upon request. ADM soy lecithin products produced under this program may be only be available in limited quantities.
